**ORDINANCE NO. 2024 – OR – 007**

**AN ORDINANCE REPEALING AND REPLACING §130.04 OF THE CODE OF ORDINANCES FOR THE TOWN OF SELLERSBURG, INDIANA.**

**WHEREAS**, pursuant to Ind. Code § 36-5-2 *et seq.*, this Town Council of Sellersburg, Indiana (this “Council”) is the town legislative and fiscal bodies for Sellersburg, Indiana (the “Town”) and the President of this Council is the Town Executive; and,

**WHEREAS**, pursuant to Ind. Code § 36-5-2-9, the legislative body may adopt ordinances and resolutions for the performance of functions of the Town; and,

**WHEREAS**, this Council has determined a need to repeal and replace the section governing Basketball Goals for the Code of Ordinances for the Town.

**NOW THEREFORE BE IT ORDAINED** by this Town Council of Sellersburg, Indiana as follows:

1. Section 130.04 of the Code of Ordinances is hereby repealed and replaced with the following language:

The Town Manager or it’s designee may take action against any property owner who allows a basketball goal to be placed in, on, or within the streets of the Town including respective right-of-way to have said basketball goal removed from said location.

Notice shall be posted on the basketball goal and notice served to the resident by certified mail. The resident must remove the basketball goal from the road and/or right-of-way within thirty (30) days of the date of the notice. Any failure to cure said violation within the thirty (30) day period shall result in a fine of \$25.00 per day starting on the thirty-first (31<sup>st</sup>) day after the date of notice.

All fines shall be collected by the Clerk-Treasurer and deposited into the Streets and Sanitation Fund. Should the Town have to seek legal action to collect the fines, the Town reserves the right to seek attorney’s fees and costs where appropriate and not otherwise prohibited by law.

2. This ordinance shall be in full force and effect after its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Council and thirty (30) days after its publishing in the News and Tribune or another acceptable publication.
3. The Executive Secretary is hereby charged with the responsibility of causing said ordinance to be published per Indiana law.
