**ORDINANCE NO. 2024 – OR – 018**

**AN ORDINANCE ESTABLISHING A NON-REVERTING FUND  
TITLED THE “SPD K9 PROGRAM FUND”.**

**WHEREAS**, pursuant to Ind. Code § 36-5-2 *et seq.*, this Town Council of Sellersburg, Indiana (this “Council”) is the town legislative body and the President of the town council is the town executive; and,

**WHEREAS**, pursuant to Ind. Code § 36-5-2-9, the legislative body may adopt ordinances and resolutions for the performance of functions of the town; and,

**WHEREAS**, pursuant to Ind. Code § 36-1-3 *et seq.* (i.e. “Home Rule”), a unit may exercise any power it has to the extent that the power is not expressly denied by the Indiana Constitution or by statute and is not expressly granted to another entity; and,

**WHEREAS**, this Council has determined a need to establish a non-reverting fund titled “SPD K9 PROGRAM” to provide and take care of a police dog to serve the the Town of Sellersburg, Indiana.

**NOW THEREFORE BE IT ORDAINED** by this Town Council of Sellersburg, Indiana the following:

1. “SPD K9 PROGRAM FUND” is hereby established and shall be a non-reverting fund. The fund will be supported by the donations collected from the general public and businesses.
2. The Police Chief shall have the discretion and authority to use the monies of said fund, without limitation, provided the expenditure adheres to the laws of Indiana and is related to the care and training of police K9s and their handlers of the Town of Sellersburg, which includes but is not limited to, police officer salaries, professional services, equipment, vehicles, computer software, subscriptions, etc.

- This ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Council.

**ORDINANCE NO. 2024-OR-019**

**AN ORDINANCE AMENDING HEALTH INSURANCE BENEFITS FOR TOWN OF SELLERSBURG, INDIANA EMPLOYEES AND PREMIUM RESPONSIBILITIES**

**WHEREAS**, pursuant to LC. 35-5-2 *et seq.*, this Town Council of Sellersburg, Indiana (this "Council") is the town legislative body, and the president of this Council is the town executive; and,

**WHEREAS**, this Council has previously adopted Ordinance No. 2015-OR-014 "*Ordinance Establishing Health Insurance Benefits for Town of Sellersburg Employee and Premium Responsibility*," which set forth certain percentages this Council and the employee(s) were to pay for health insurance benefits; and,

**WHEREAS**, from time to time, this Council finds it necessary to amend certain ordinances.

**NOW, THEREFORE BE IT ORDAINED** by this Town Council of Sellersburg, Indiana the following:

1. Ordinance No. 2015-OR-014 is hereby repealed and replaced by this ordinance.
2. This Council shall pay 97% of the total premiums on behalf of the employee and the employee shall pay 3% for health insurance for said employee.
3. This Council shall pay 65% of premiums and the employee shall pay the other 35% for health insurance for employee's dependents.
4. This ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving member of this Council.
