ORDINANCE NO. 2025 – OR – 018

AN ORDINANCE CONSIDERING AN AMENDMENT TO THE ZONING MAPS OF THE TOWN OF SELLERSBURG, INDIANA.

WHEREAS, pursuant to Ind. Code § 36-5-2 *et seq.*, this Town Council of Sellersburg, Indiana (this "Council") is the town legislative body and the President of the town council is the town executive; and,

WHEREAS, pursuant to Ind. Code § 36-5-2-9, the legislative body may adopt ordinances and resolutions for the performance of functions of a town; and,

WHEREAS, on the 18th day of August, 2025 the Plan Commission of the Town of Sellersburg, Indiana (the "Commission") certified a <u>favorable</u> recommendation to rezone the certain properties identified hereafter, 1005 Bean Rd. Parcel ID 10-17-06-700-022.000-031 from I1 Light Industrial to I2 Heavy Industrial and 1017 Bean Rd. Parcel ID 10-17-06-700-029.000-031 from I1 Light Industrial to I2 Heavy Industrial and a portion of 1128 Bean Rd. Parcel ID 10-17-06-700-025.000-031 from B3 Highway Business to I2 Heavy Industrial (collectively referred to as the "Properties") (See Attached Exhibit A); and,

WHEREAS, pursuant to Ind. Code § 36-7-4-608, this Council may adopt or reject the certification from the Commission.

NOW THEREFORE BE IT ORDAINED by this Town Council of Sellersburg, Indiana that the recommendation by the Commission to rezone the Properties from I1 Light Industrial and B3 Highway Business to I2 Heavy Industrial is hereby Adopted / Rejected (circle one).

ORDINANCE NO. 2025 - OR - 019

AN ORDINANCE AMENDING CHAPTER 51 "GARBAGE AND REFUSE" OF THE CODIFICATION OF THE ORDINANCES FOR THE TOWN OF SELLERSBURG, INDIANA.

WHEREAS, pursuant to Ind. Code § 36-5-2 et seq., this Town Council of Sellersburg, Indiana (this "Council") is the town legislative body and the President of the town council is the town executive; and,

WHEREAS, pursuant to Ind. Code § 36-5-2-9, the legislative body may adopt ordinances and resolutions for the performance of functions of the town; and,

WHEREAS, pursuant to section 51.04(A), "The monthly service charge for the Town of Sellersburg to pick up one refuse container is \$10 per container per residence.;" and,

WHEREAS, pursuant to section 51.04(B), "A resident of the Town of Sellersburg has the option of purchasing up to two garbage cans from the Town of Sellersburg for \$75 per garbage can.;" and,

WHEREAS, this Council recently conducted a cost-analysis audit of the garbage and refuse expenses and determined the Town of Sellersburg, Indiana (the "Town") does not generate enough revenue to cover the costs of providing garbage and refuse services, which ultimately takes away from other services provided by the Town; and,

WHEREAS, from time to time, this council finds it necessary to amend certain ordinances.

NOW THEREFORE BE IT ORDAINED by this Town Council of Sellersburg, Indiana the following:

1.	Section 51.04(A) is hereby repealed and replaced with the following language:	
	The monthly service charge for the Town of Sellersburg to pick up a refuse container is \$ per container per residence with a maximum of 2 containers.	
2.	Section 51.04(B) is hereby repealed and replaced with the following language:	
	A resident of the Town of Sellersburg has the option of purchasing up to two (2) refuse containers from the Town of Sellersburg for equal to and not exceeding the actual cost of the container the Town incurred to acquire it including any freight charges associated with delivery.	
3.	All other sections of Chapter 51 remain unaffected by this Ordinance and continue to be in full force and effect.	
4.	This ordinance shall be in effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Council.	
5.	This ordinance shall be in full force beginning the day of, 20 as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Council.
