ORDINANCE NO. 2025 – OR – 026

AN ORDINANCE AMENDING ORDINANCE NO. 2009-028: AN ORDINANCE ESTABLISHING A RETIREES INSURANCE FUND FOR RETIRED EMPLOYEES OF THE TOWN OF SELLERSBURG.

WHEREAS, pursuant to Ind. Code § 36-5-2 et seq., this Town Council of Sellersburg, Indiana (this "Council") is the town legislative body and the President of the town council is the town executive; and,

WHEREAS, pursuant to Ind. Code § 36-5-2-9, the legislative body may adopt ordinances and resolutions for the performance of the functions of the town; and,

WHEREAS, from time to time, this Council amends previously adopted ordinance; and,

WHEREAS, this Council now desires to amend Ordinance No. 2009-028 An Ordinance Establishing A Retirees Insurance Fund For Retired Employees Of The Town Of Sellersburg.

NOW THEREFORE BE IT ORDAINED by this Town Council of Sellersburg, Indiana the following sections of said ordinance are hereby modified as follows:

- 1. Section 3-7 repealed.
- 2. Section 9 is hereby replaced and repealed as follows:
 - a. Funds for the Retirees Insurance Fund shall originate from the General Fund, the Town of Sellersburg Water Utility and the Town of Sellersburg Sewer Utility.
- 3. All other sections not referenced herein are still in full force and effect and are unaltered by this ordinance.
- 4. This ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Council.
