Doug Reiter moved, second by Michael Richardson, to approve the contract and agreement as presented. Motion carried, 5-aye, 0-nay.


Project Updates:

Jacobi, Toombs, and Lanz (JTL)/Prime AE:


- Mr. Lawrence, on behalf of the JTL/Prime AE team, advised the Camp Run Area Lighting Project study continues.


